We are most pleased to announce that we are awarding seven scholarships this year, ranging from \$1,000-\$5000 to LGBT college or college bound students.

Thirteenth year: Mary Wagner Memorial Scholarship. This was established in memory of Mary Wagner by her partner, Sharon Murphy, and friends Marilyn and Art Carpenter. Mary was an elementary school teacher.

Eleventh year: John Bessemer Memorial Scholarship. The memory of John Bessemer is honored with the PFLAG-funded scholarship. John was a dedicated PFLAG dad and husband of past president Linda Bessemer.

Seventh year: Rob Benzon Memorial Scholarship. This is being presented by the Rob Benzon Foundation in mem-

ory of Rob, who died in a tragic swimming accident at age 31.

Fifth year: Stephen G. Bowersox Memorial Scholarship. Stephen's parents chose to honor Stephen with a scholarship in his memory. Stephen was a past PFLAG scholarship recipient and gay rights activist.



Fifth year: The San Diego Human Dignity Foundation is providing the scholarship from the John McCusker Memorial Fund. John, who was active in the gay community, died suddenly at age 31 of congestive heart failure.

Second year: San Diego Chapter of Raytheon GLBTA Scholarship. This will be awarded to an GLBTA student pursuing the STEM field (science, technology, engineering or math).

First year: The San Diego Human Dignity Foundation is providing the scholarship from the Richard Geyser Memorial Ethics Fund. This scholarship was established through a bequest by Philip Flick to honor his partner of 44 years, Richard Geyser.

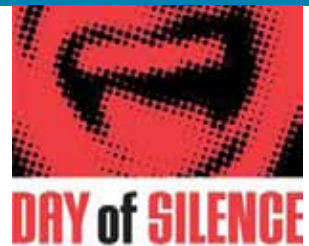

It was started by GLSEN (Gay, Lesbian, Straight Education Network) as a call for action to protest bullying and harassment of LGBT students and their supporters. Students take a day-long vow of silence to symbolically represent the silencing of LGBT students and their supporters.

Hundreds of thousands of students will participate in over 8000 schools ranging from middle school through college. Those students who are not able to participate the entire day are asked to keep the vow of silence for a portion of the day.

IF IT'S NOT THE ONE MILLION MOMS, IT'S NOM

NOM (National Organization for Marriage) is bent out of shape again. This time they are up in arms that Starbucks declared its support for same-sex marriage during Washington State's marriage equality push in January. Although Starbucks was joined by companies including Amazon, Google, Microsoft and Nike, NOM probably figured they could do the most harm to Starbucks. After all, they most likely weren't about to give up Microsoft software they use in their offices or ban employees from owning iPhones. So, NOM launched an international "Dump Starbucks" campaign. To save you time from looking it up, here is the bulk of it: "We are urging customers across the globe to 'Dump Starbucks' because it has taken a corporate-wide position that the definition of marriage between one man and one woman should be eliminated and that same-sex marriage should become equally 'normal'. As such, Starbucks has deeply offended at least half its US customers, and the vast majority of its international customers. In many areas of the world where Starbucks does business, the concept of 'gay marriage' is unheard of and deeply offensive to cultural, moral and religious values. In taking these actions, Starbucks has declared a culture war on all people of faith (and millions of others) who believe that the institution of marriage as one man and one woman is worth preserving." And the worse of it: "A portion of every cup of coffee purchased at a Starbucks anywhere in the world goes to fund this corporate assault on marriage." Perish the thought. The last part of their message is, of course, to encourage you to join the "Dump Starbucks" campaign.



NOM supporters will reportedly distribute ads throughout the U.S., the Middle East and southeast Asia calling for customers to boycott the chain. No doubt, the opposite effect will happen.

After that, it's good to hear Starbucks' point of view. Kalen Holmes, Starbucks' Executive Vice President said, "This important legislation is aligned with Starbucks business practices and upholds our belief in the equal treatment of partners. We are deeply dedicated to embracing diversity and treating one another with respect and dignity, and remain committed to providing an inclusive, supportive and safe work environment for all of our partners."

On another positive side, on April 11, supporters of Starbucks delivered a giant thank you card with about 40,000 signatures, a gesture commending the company for publicly expressing its support of same-sex marriage in Washington State. Almost 650,000 people virtually signed a thank you card online.

MIGHT MAKES RIGHT

The documentary, “Bully,” is an account of five families who were affected by bullying on school busses and in schools during the 2009-2010 school years. The actual footage will take you aback and is, no doubt, an emotionally difficult film to watch. Unfortunately, it was first rated R, leaving out millions of school children under 17 years old who would benefit the most from seeing the film. The main reason for the R rating was the language in the documentary. It became a drawn-out battle of wills among the studio, the trade association responsible for the voluntary ratings system, and vocal advocates of anti-bullying initiatives to get the rating changed to PG-13. To accomplish the change, a number of the “F-bombs” had to be dropped for the theatre distribution of the film (which opened nationwide on April 13).

Joan Graves, head of the Motion Picture Association of America, said, “If all children and parents are not allowed to see this documentary, it will defeat its purpose to generate higher awareness of the bullying epidemic and education of what bullying truly looks and feels like. Thirteen million children being bullied everyday is 13 million too many.”

“Putting anything in the way of kids seeing this movie – kids who could well be victims of

bullying themselves – was not only foolish but destructive,” said Paul Levinson, author of “New New Media.” (the New New is correct)

Then there’s the power of one. Seventeen year-old Katy Butler from Ann Arbor, Michigan started a grassroots campaign to get the rating changed for the documentary in late February. In a few short weeks, she harnessed the power of the Web to gather more than 500,000 supporters for a petition aimed at allowing a wider audience to see “Bully,” a movie which she thought, and rightly so, could be a powerful force for the anti-bullying movement.

Aside from Katy being all over the U.S. as an envoy for the film, she has met several supportive actors, and appeared on talk shows with Anderson Cooper and Ellen DeGeneres. She even got to talk her anti-bullying policy with members of Congress.

A good lesson in what the power of one can do.



OUTSERVE FEATURES TRANSGENDER SERVICE MEMBERS

In January’s issue of *OutServe Magazine*, six current transgender service members and veterans were featured in an article, *The New DADT: Transgender Service*. For some of the members, this was the first time their stories have been shared in public.

The article highlights the daily challenges transgender people face serving in silence, and urgently needed policy changes. Despite the repeal of “Don’t Ask, Don’t Tell,” open transgender military service remains banned due to outdated military medical regulations.

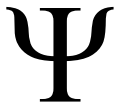
